DEFENDANT’S SUPPLEMENTAL STATUS REPORT

The Department of Education (“DOE”) hereby submits its Supplemental Status Report which supplements its prior Status Report Filed September 30, 2014 in accordance with the Court’s August 22, 2014 Order - ECF Doc No. 187 (“August 22 Order”).

For category two (2) of the August 22 Order, the DOE has the ability to provide the compensatory education to the ERK class members. Based on the identification of ERK class members by ERK class counsel to date, the DOE has staffing that can provide the compensatory education for the ERK class members to address their respective needs. The DOE has staffing that provides services required under the IDEA such as speech-language pathology, psychological services, autism-related services, physical therapy, occupational therapy, and transition services.

For category three (3) of the August 22 Order, as needed, the DOE also contracts with the following private service providers that provide services required under the IDEA as follows:

Educational Based Services (EBS) provides occupational therapy, physical therapy, and speech-language pathology;

RCM Health Care provides skilled nursing;

Hawai’i Behavioral Health, LLC and Mind & Body Works, Inc. provide psychiatric services and medical management;

Alaka'i Na Keiki, Inc., Aptitude Habilitation Services, BAYADA Home Health Care, Behavior Analysts, Inc., CARE Hawaii, INC., Hawai'i Behavioral Health, LLC, Maui Youth and Family Services, INC., and TRUMPET Behavioral Health provide paraprofessionals and behavioral instructional support services (BISS).

The parties have been in discussions with Magistrate Judge Chang on various matters since the August 22, 2014 Order; the DOE is open and willing to obtain the services of other private services providers that are able to provide compensatory education services for ERK Class Members that the DOE may be unable to provide.
