JUDGMENT AS TO THE PERIOD FOR CLASS CLAIMS, FILED OCTOBER 25, 2013**

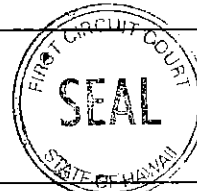

No such separate lawsuit shall be consolidated with this case.
